1. Welcome by the Chair, Fionnuala Stott

The Chair welcomed all to the meeting.

2. Apologies for Absence

3. Minutes of the 2022 AGM

4. Matters Arising

5. Chair's Report

Fionnuala Stott, Chair, report received. The following points detailing the past year's LOC activity were noted:

- Working closely with PES
- Building relationships with our Primary Care colleagues and raising awareness of the services we offer.
- Providing Optometry representation on the Cheshire and Merseyside ICS Primary Care forum.
- Working with our three Hospital Trusts to support them in their recovery since COVID-19 and help reduce the pressure on the Hospital Eye Service.
- Representing the views of our members when engaging with our NHS colleagues and commissioners.
- Keeping our members up to date via regular newsletters.

A strategy day had been held in January when it was agreed the LOC should focus attention on the following:

• Engagement with any newly qualified Optometrists and Dispensing Opticians in our area.

- Update and make the website more user friendly and easier to follow the referral pathways.
- Improve practice uptake to extended services and better signposting from non-participating practices to participating practices.
- Work with GP practices and Pharmacies to better signpost patients.
- Improve our communications. We are always striving to communicate better with our members and reach a wider audience.

Some successes over the past year:

- PES has paid £550k to practices for extended services over the past year; £412k was for CUES alone.
- We average approx. 880 CUES episodes per month across Cheshire.

The Chair wished to record her thanks to the committee for their work to date. Lyndon Taylor had been a huge support during his tenure as Chair to the committee and members, and latterly to the new Chair, Fionnuala Stott; Lyndon had not stood for election this year and would stand down. The committee wished to note their thanks to Lyndon.

6. Election Result

David Knowles acted as Returning Officer for the 2023 Election; in 2023 there were 3 Contractor seats elections and 3 Performer seat elections.

The Contractors voted in were Mark Simpson, Amy Thompson and Jill Umpleby.

The Chair wished to thank all those who were nominated. All members were very welcome to attend LOC meetings as observers.

7. Treasurer's Report
