Serious Incident Reporting Requirements from 1 October 2013 Re:

David Sharp, Area Director (Leics & Lincs)

As from the 1 April 2013 NHS England has been responsible for the management of serious incidents across Primary Care. The Area Team, in discussion with CCG's arranged for this process to be retained by the CCG's within Leicestershire & Lincolnshire for a period of 6 months to enable the Area Team to establish local systems and processes to manage this going forwards.

From 1 October 2013 the Area Team requires all Primary Care Independent Contractors to report serious incidents/never events directly to The Leicestershire & Lincolnshire Area Team as per the requirements within the Serious Incident Framework (March 2013).

A serious incident can be defined as an incident that occurs during NHS funded healthcare. which results in unexpected death or severe harm, allegation or incidents of physical abuse, sexual assault or abuse, loss of confidence in the service, adverse media coverage or public concern about an organisation.

Serious incidents requiring investigation in healthcare are rare, but when they do occur, everyone must make sure there are systematic measures in place to respond. These measures must protect patients and ensure that robust investigations are carried out, which result in organisations learning from serious incidents to minimise the risk of the incident happening again.

To assist you with the reporting and investigation of serious incidents the following documents are attached:
