## Appendix 2 URGENT EYE CARE SERVICE IN PRIMARY CARE OPTICAL PRACTICES.

The Community Ophthalmic Referral Refinement Scheme (CORRS) and Covid Urgent Eye Care Service (CUES) allows North/North East Lincolnshire patients with certain symptoms to be seen free of charge at NHS approved, accredited opticians across Northern Lincolnshire. The list of opticians is above.

Patients suffering with one or more of the following symptoms can be seen for treatment, advice or onward referral as necessary:

- Red/irritable eyes
- Sore and painful eyes
- Sudden or recent vision changes
- Flashes and floaters

To use this service free of charge patients must be registered with a GP in the North Lincolnshire or North East Lincolnshire area and have one of the above eye problems. Patients do not need to register with the selected Opticians.

This is only available in the list of practices that are participating in the scheme.

A referral can be made to any of these practices by calling the practice or asking the patient to contact the practice stating their Symptoms, Onset and Personal information a series of questions will be asked in order to allocate an appropriate appointment.

Note: This is an appointment-based referral and patients are advised to call the participating practice for triage for same day (Urgent) or within 5-7 days (Soon) referral is made.

All practices can see a patient from either area.
